EVENT CONDITIONS OF PLAY

EVENT STRUCTURE:

Two sides of fourteen (14) men & fourteen (14) women.
 Each side shall contain a designated "A" (Senior) squad of seven (7) players and a "B" squad of seven (7) players.

2) Two rounds of play

a. Morning round:- 2x4x2 Pairs – each pair containing an "A" & "B" squad player

The "B" squad player to 'lead off'.

b. Afternoon round:- "A" squads vs "A" squads, "B" squads vs "B" squads

Each squad with teams of Singles, Pairs & Fours.

3) Match Points:- Morning Round Win = 2pt, Draw = 1pt, Loss = 0pt.

Afternoon Round Win = 3pt, Draw = 1pt, Loss = 0pt.

CONDITIONS OF PLAY:

4) Format

2x4x2 Pairs 15 ends
Singles 21 shots
Pairs 18 ends
Fours 15 ends
No time limit for any discipline.

5) Player positions may be changed within a discipline but not move between disciplines

6) **Start times:** 9:30am Welcome, orientation and house-keeping.

Morning Round **10am** (9:45am for trial ends)
Afternoon Round **12:45pm** (12:30pm for trial ends)

Prize Giving 3:30pm

Morning tea available from 9:15am

Lunch break after 1st round, afternoon tea after 2nd round.

Lunches may be ordered from PBBC if required.

7) Two (2) points [2x4x2] or three (3) points [all afternoon disciplines] will be awarded for each game won. One point will be awarded for each game drawn.

The men's and women's matches are scored separately.

A trophy will be awarded for each of the Mens & Womens matches.

If any event outcome is equal, then a differentials count will break any tie.

8) Team lists to be presented to Event Controller (via Bowls Kapiti Coast Admin) by Monday 23rd November for inclusion in Draw documentation. Unavoidable changes to teams to be presented to the Event Controller prior to play.

EVENT PROTOCOLS

- a) The Controlling Body have the right to amend the times when deemed necessary.
- b) Greens Green selections are subject to confirmation in the Draw and subject to changes due to environmental conditions on the day.

 Greens will not be changed between rounds unless required by condition or weather.
- c) A single 'coin-toss' for each of the Men's & Women's sides is to be made by the sides 'captains' at the beginning of each round to determine who has the lead decisions.
- d) The 2x4x2 Pairs match-ups will be randomised within the draw from the initial order supplied in the team lists by the team selectors.
- e) In the case of inclement weather the Controlling Body may alter conditions and impose time limits.
- f) A joint managers/selectors meeting after the 1st round will confirm conditions & format for the next year.

The Bowls NZ & Bowls Kapiti Coast standard regulations as described in the Core Conditions of Play on the Bowls Kapiti Coast Website under "Representative Events" under the "Events & Results" tab on the Homepage, are in use

- providing they are relevant to Representative Events
- are over-ridden by terms in these Event Condition of Play
- in the case of ambiguity or conflict of meaning, then these Event CoP take precedence.
